

**RESOLUTION BY THE MADISON ATHENS-CLARKE OCONEE

WHEREAS, administrative modifications to the Transportation Improvement Program (TIP) must be approved by the MACORTS Policy Committee and,

WHEREAS, the Georgia Department of Transportation's State Transportation Improvement Program (STIP) and the MACORTS TIP must match, the following items have been administratively modified in the FY 2015 – 2018 Transportation Improvement Program following the transportation planning process:

Section 5339 Capital Funding was increased from a total of \$2,500,000 (\$2,000,000 federal; \$500,000 local) to \$3,204,397 (\$2,563,518 federal; \$640,879 local) in the following activity line items:
